## INVITATION TO BID

The **Department of Health – National Capital Regional Office (DOH-NCRO)**, through the GOP funds – **CY 2018** intends to apply the sum of the following goods being the Approved Budget for the Contract (ABC) to payments under the contract. Bids received in excess of the ABC shall be automatically rejected at Bid opening.

The DOH-NCRO now invites sealed Bids, from eligible Bidders for the Procurement of GOODS and Infrastructure. Delivery of GOODS is required by **4<sup>th</sup> Quarter of CY 2018**. The description of an eligible bidder is contained in the Bidding Documents, Section II. Instructions to Bidders:

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (R.A. 9184), otherwise known as the Government Procurement Reform Act, and is restricted to organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, as specified in Republic Act 5183 (R.A. 5183). Only Bids from Bidders who pass the Technical Eligibility check will be opened. The process for the Technical Eligibility check is described in Section II of the Bidding Documents, ITB. The bidder with the lowest calculated bid (LCB) shall advance to the post-qualifications stage in order to finally determine his responsiveness to the technical and financial requirements of the project. The contract shall then be awarded to the Lowest Calculated and Responsive Bidder (LCRB) who will be determined as such during the post-qualification procedure.

A complete set of Bidding Documents may be acquired by interested Bidders *from the address below* and upon payment of a nonrefundable fee from **November 5 – 21, 2018**. The method of payment will be in cash. Bidding Documents fee are based on *the latest Guidelines issued by the GPPB*.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the non-refundable fee for the Bidding Document as per scheduled:
