INVITATION TO BID

The Metro Manila Center for Health Development (MMCHD), through the GOP/SAA funds – CY 2022 intends to apply the sum of the following amounts being the Approved Budget for the Contract (ABC) as payment for the procurement of identified goods/services.

1. The MMCHD now invites bids for the Procurement Projects listed below. Completion of the Works is required within Three (3) years. Bidder should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II. Instructions to Bidders:

- 2. Bidding shall be conducted using open competitive bidding procedures and non-discretionary "pass/fail" criteria as specified in the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (R.A. 9184), otherwise known as the Government Procurement Reform Act.
- 3. Bidding is restricted to Filipino citizens (sole proprietorship), partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Interested Bidders may obtain further information from the Bids and Awards Committee (BAC) Secretariat Office (c/o Ms. Ma. Rosanna C. Fariñas) at telephone number 8-531-0034/37 local 308 and inspect the Bidding Documents at the address given below from Monday to Friday from 8:30 am to 4:00 pm., except holidays.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders from the address below and upon payment of a non- refundable fee from April 5, 2022 to April 25, 2022. The method of payment shall be in cash payment. Bidding Documents fee are based on the latest Guidelines issued by the Government Procurement Policy Board (GPPB).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the MMCHD, provided that bidders shall pay the non-refundable fee for the Bidding Document not later than the submissions of their bids.

6. The MMCHD shall hold a Pre-Bid Conference at DOH-MMCHD Amphitheater, Block 6, Barangay Road, Welfareville Compound, Brgy. Addition Hills Mandaluyong City, which shall be open to all interested bidders per herein schedule:

Bids must be duly received by the BAC Secretariat through manual submission at the MMCHD Amphitheater, Acacia Lane, Welfareville Compound, Barangay Addition Hills, Mandaluyong City on or before time and date scheduled below. Bids shall be opened in the presence of the Bidders' representatives who choose to attend as stated:

LATE BID SHALL NOT BE ACCEPTED. UNSEALED OR UNAMARKED BID ENVELOPES SHALL ALSO BE REJECTED.

- 8. All bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. The MMCHD reserves the right to accept or reject any and all bids, declare a failure of bidding, or not award the contract any time prior to contract award in accordance with Section 35.6 and Section 41 of the 2016 Revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders. Bids received in excess of the ABC shall be automatically rejected at Bid Opening.
