The equipment must be functioning and must have no physical damage and defect. 4. Warranty a) Warranty certificate for two (2) years on parts and service. The supplier shall either repair or replace any item or part in the equipment that is found to be defective in material or workmanship under normal use. The warranty period shall commence from the date of acceptance by the end-user after testing and commissioning. b) Corrective maintenance within five (5) calendar days upon notification from the end-user regarding equipment breakdown/defects. c) The number of days where the equipment is unusable due to equipment defects/faults shall be added to the warranty period. d) The supplier shall specify post-warranty comprehensive preventive maintenance costs including list and prices of major spare parts of the

equipment for three (3) years after the warranty period.

3. **Notarized undertaking** that the supplier shall conduct the necessary corrective maintenance within five (5) calendar days upon notification of the equipment breakdown from the end-user. The undertaking shall include a statement that the number of days where the equipment is unusable due to defective material or workmanship, shall be added to the warranty period.
