- Air purifier with multi-stage air filter (Pre-filter, HEPA, Carbon) and with UV light. The size of air purifier must be appropriate for the ambulance.

 - Styrene (ABS) plastic material and with lid cover. The container must be properly labelled and must be mounted on the ambulance floor.
