2. <b>Testing</b> : Prior to acceptance, the end user shall conduct a physical						
inspection and functionality test. The equipment must be						
functioning and must have no physical damage and defect.						
3. <b>Training</b> : The supplier shall provide a training on the proper use						
and maintenance of the equipment to the end-users and to the						
hospital maintenance staff within 3 day	ys upon the	delivery of the				
equipment.						
4. Warranty:						

a) Warranty certificate for two (2) years on parts and service. The

supplier shall either repair or replace any item or part in the equipment that is found to be defective in material or in workmanship under normal use. The warranty period shall commence from the date of acceptance by the end-user after testing and commissioning.

- b) Preventive maintenance at least every six (6) months or according to the manufacturer's recommendations.
- c) Corrective maintenance within five (5) calendar days upon notification from the end-user regarding equipment breakdown/defects
- d) The number of days where the equipment is unusable due to equipment defect/faults shall be added to the warranty period. at least every six (6) month or according to the manufacture's recommendation:
- 5. **Notarized undertaking** that the supplier shall conduct the necessary corrective maintenance within five (5) calendar days upon notification of the equipment breakdown from the end-user. The undertaking shall include a statement that the number of days where the equipment is unusable due to defective material or workmanship, shall be added to the warranty period.
- 6. **Manuals**: The supplier must provide the end-user one (1) hard and one (1) soft copy of the following:
  - a) Service manual in English language
  - b) Operation manual in English language
- 7. With "**DOH-MMCHD HFEP**"(Government Property not for sale) sticker in each unit
