INVITATION TO BID FOR

IB 2018 – 485 Procurement of 2,328 rolls of Insecticide Treated Screen, 25 meters per roll

1. The DEPARTMENT OF HEALTH – NATIONAL CAPITAL REGIONAL OFFICE, through the *GOP Fund*³ intends to apply the sum of **Nineteen Million Nine Hundred Ninety Nine Thousand Eight Hundred Forty Eight Pesos (Php 19,999,848) only** being the Approved Budget for the Contract (ABC) to payments under the contract for **Procurement of 2,328 rolls of Insecticide Treated Screen, 25 meters per roll**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Department of Health – National Capital Regional Office now invites bids for **Procurement of 2,328 rolls of Insecticide Treated Screen, 25 meters per roll**.⁴ Delivery of the Goods is required Bidders should have completed, within Fifteen days from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
 - (i) **Select this paragraph if conditions (a), (c), and (d) under Section 23.4.1.2 of the IRR of RA 9184 do not exist:** Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information from Department of Health – National Capital Regional Office (DOH-NCRO), Mandaluyong City at BAC Office c/o BAC Secretariats and inspect the Bidding Documents at the address given below during office hours from 8:30 AM – 4:00 PM Monday to Friday.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **November 8 - 29, 2018** from the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty Five Thousand Pesos (Php 25,000.00) only*. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System

(PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Department of Health – National Capital Regional Office will hold a **Pre-Bid Conference⁵** on **November 15, 2018, 9:00 AM** at **DOH-NCRO Amphitheater, Mandaluyong City**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address given below on or before **November 29, 2018 at 9:30 AM at the DOH-NCRO Amphitheater**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on **November 29, 2018 at 9:45 AM at the DOH – NCRO Amphitheater, Mandaluyong City**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The **Department of Health – National Capital Regional Office** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
