ANNEX "A"

INSTRUCTIONS TO BIDDERS AND TERMS OF CONDITIONS OF SALE FOR DISPOSAL THROUGH AUCTION OF VARIOUS WASTE MATERIALS

1. All sealed bids shall be submitted to the Waste and Disposal Committee Secretariat, 1st floor Building 3, Metro Manila Center for Health Development.

The complete set of documents to be submitted shall include the following:

- a) Bid Proposal
- b) Bidder's Bond equivalent to at least (10%) of the total value of the offer in the form of cash
- c) Copies of the following:-DTI/SEC, Business Permit, BIR Registration/TIN
- 2. The bidder's bond will be returned to the non-winning bidder right after the bidding. On the other hand, the bid bond of the winning bidder shall form part of the purchase price. However, the ten percent (10%) bid bond shall be forfeited if the full price is not paid by the winning bidder within the prescribed period stated in the Notice of Award. The bid bond shall be considered as partial payment and the difference between such payment and the area where the bidding was held. Full payment shall be made within three (3) working days from the date of the receipt of Notice of Award.
- 3. Unsigned bid proposals shall automatically be rejected during the opening.
