Individual Tax Registration vis-à-vis Substituted Filing of Taxes Withheld from Personnel Hired under Contract of

Service (including those under Deployment

Program/Project)

As filing with the Bureau of Internal Revenue (BIR) for taxes withheld has inconvenienced those personnel hired under Contract of Service, please be informed that the National Capital Regional Office shall opt for Substituted Filing of Tax Returns for appropriate withholding taxes on income payments to them (all Job Order, including those under Deployment Program/Project). Under Substituted Filing, there will only be Annual Income Tax filing and no Authority to Print (ATP) - substituted official receipts and books required.

However, in order to facilitate the said Substituted Filing, those concerned must register first with the Revenue District Office-Mandaluyong City using the address of National Capital Regional Office (NCRO) as the common address thereof provided that the DOH-NCRO is their lone payor/lone source of income. Accordingly, the personnel submit the documentary requirements corresponding to their respective classifications as enumerated hereunder, to wit:

Furthermore, those who will opt for Substituted Filing will have to execute a Special Power of Attorney to authorize the Office through the designated personnel holding plantilla position to facilitate the filing thereof.

Accordingly, all the corresponding documentary requirements and duly executed Special Power of Attorney must be submitted on or before May 19, 2017, as follows:
